Delinquent dues payments must be paid no later than one month prior to the tournament's entry closing date to insure a player's eligibility. **THE CLUB MUST BE LOCATED IN THE PSWGA EASTERN DIVISION.** PSWGA reserves the right to fill the field after entry closing if it is undersubscribed.

9:00 A.M. - Shot Gun Start, Lunch and awarding of prizes immediately following play  
Please be advised that Waynesborough CC does not allow metal spikes.
